A working knowledge of Avantis, TWR, GIS and Great Plains software would be an asset. Supervisory experience, including oversight of contractors, would also be an asset. You must possess strong computer skills and be able to execute technical tasks with particular attention to detail. Excellent planning, organizational, customer service and contract administration skills, with a keen focus on safety and the environment, are essential to the position.
